With reference to the subject and reference cited above I am to enclose herewith the statement showing the salary due to the employees of your Institution from the month of January 1978 duly approved for taking further action. The salary now approved shall be in force for the period from 1-1-1978 to 31-12-1978. Before authorising the payment of salary to the staff, the Principal is requested to see/minimum qualification (viz. Master's Degree in II Class) and sufficient work load as prescribed. It has been observed that in the majority of the cases, the Principals have not furnished the complete information in the work load statement. While approving the new appointments during the year 1977-78 the work load furnished by the Principal has, therefore, been provisionally accepted to avoid inconvenience to the staff subject to verification of the same with due regard to the possibility of combining the classes (especially in languages) to arrive at the work load available in the respective departments) during local inspection of the college.

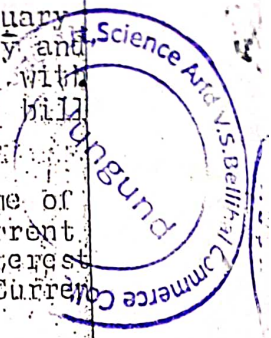
According to the Government Order No.ED 161 U.C. 77 dated 31-12-1977 teachers who possess Master's Degree in Pass Class and appointed after 13-1-1971 are not to be recognised for salary grant with effect from January 1978 as their appointments were not in accordance with the provisions of the Cadre and Recruitment Rules of this Department. Names of such teachers who are pass class Master's Degree holders as could be verified with reference to the past records available in the Directorate have not been included in the salary statement. It is possible that the salary statement might, by inadvertence include names of some teaching teachers who are pass class Master Degree holders. The Principals are therefore requested to verify the statement once again before authorising their salary for January 1978 and to report to this Directorate such cases if any included in the Salary Statement now approved.

The full-time Lecturers appointed during the year 1977-78 shall not be continued beyond 31-3-1978. However eligible persons may be paid the summer salary strictly in accordance with the provisions of G.O.No.ED 62 U.C. 60 dated 22-11-1960. As regards the Lecturers appointed against the vacancies of the teachers deputed under the U.C. scheme of Faculty Improvement Programme the salary of such persons should not be authorised from the joint account under any circumstances as the same is to be not reimbursed from the U.C. so also in case of Demonstrators deputed for I.Sc. studies. Regarding grant of increments to the employees after 1-1-1978 and before 1-1-1979 the Principal may take necessary action to allow the same after obtaining the approval of the management under intimation to this Directorate along with a detailed statement of such claim sanctioned.

The expenditure on payment of salary to staff for January may be met out of the balance of amount (two months salary and allowances) available in the joint account of the college with bank for the receipt of the countersigned Grant-in-Aid bill from this Directorate.

It has come to the notice of this Directorate that some of the colleges have opened the Joint Account in the form of Current Account. As the S.E. Account fetch the higher rate of interest on the deposits, the Principal is requested to convert the Current Account into S.E. Account immediately.
